Living Conditions

The Republic of Moldova is a landlocked country in Eastern Europe, bordered by Romania to the west and Ukraine to the north, east and south. The total area of the Republic of Moldova is 33,846 km2 with an estimated population of around 3 million. Moldova has a climate which is moderately continental; its proximity to the Black Sea leads to the climate being mild and sunny.

The summers are warm and long, with temperatures averaging about 20°C (68°F), and the winters are relatively mild and dry, with January temperatures averaging –4°C (25°F). Annual rainfall, which ranges from around 600 mm (24 in) in the north to 400 mm (16 in) in the south, can vary greatly; long dry spells are not unusual. The heaviest rainfall occurs in early summer and again in October; heavy showers and thunderstorms are common. Because of the irregular terrain, heavy summer rains often cause erosion and river silting.

Basic health facilities and food are available everywhere. However, the COVID-19 pandemic has a strong blueprint on the everyday life. The average number of daily COVID-19 cases during the lst week are at 400 – 500. The total number of reported cases stands at 41,704 by September 10. The total number of active cases reached 10,666. The overall crude cumulative incidence of cases per 100,000 stands at 1,200, placing Moldova near the top of countries with the highest incidence of cases in Europe and in the region.

In the Republic of Moldova, UNFPA has been active since 1995 and is currently implementing its 3rd Country Programme for 2018-2022. The aim of the Programme is to support women and young people realize their sexual and reproductive health and rights, fostering gender equality, youth life-skills and youth empowerment; and to build the demographic resilience of the country through intergenerational dialogue between young and old and the availability of quality data on population dynamics. In the area of sexual and reproductive health and rights, under its 3rd Country Programme for 2018-2022, UNFPA Moldova supports the national Government's efforts in developing and implementing policies and programs on sexual and reproductive health and rights, aiming to increase access to quality family planning services and modern methods of contraception; save women's life through cervical cancer prevention; protect people from STIs and HIV, particularly the most at risk populations; address gender-based violence; ensure preparedness to respond to SRH needs of the population in the context of public health emergencies; promote equal rights and advocate for improving access to sexual and reproductive healthcare for women and girls with disabilities etc.

UNFPA Moldova Country Office will start in 2021 the preparations for the 4th cycle of the Country programme development. The new UNFPA CPD 2023-2027 of the Republic of Moldova will respond to the national needs and contribute to the implementation of the Nairobi commitments and achievement of the ICPD Agenda and Sustainable Development Goals. It is anticipated that it will continue to have a strong focus on Sexual and Reproductive Health, and particularly on the SRHR of the most marginalized and vulnerable populations, including people with disabilities.
